Dear Friends,

We invite students, post-graduate students, and young scholars up to 35 years old (who do not hold post-graduate degrees) specializing in different fields of sciences and arts to participate in the IX Annual Smolny International Student Conference 'Interdisciplinarity in Science and Arts: Reality 2.0'. The conference will be held on April 17-19, 2020 at the Bobrinskiy Palace (58-60 Galernaya St, Saint Petersburg, Russia).

The upcoming conference is devoted in the first place to the topic of changing reality in all its manifestations. We named it 'Reality 2.0' and we invite all participants to think about the reality we are living in, how this reality is explored by science and art, and what alternatives are awaiting us in the future.

This year Smolny Conference program will include panel presentations, roundtable discussions, workshops, lectures of leading scholars and teachers from St. Petersburg State University, as well as a short film festival, show-debate and other events, offering students from different countries great opportunities for networking and collaboration.

The working languages of the Smolny Conference are English and Russian.

Conference has no registration fee.

Topics include but are not restricted to:

- Visual Arts
- Music and Theatre
- Natural Sciences (Cognitive Studies, Complex Systems, Computer Sciences and Artificial Intelligence, Life Sciences)
- Social Sciences
- Political Sciences
- History
- Philosophy
- Philology and Literature

Please note that this is the list of spheres our conference works in, not the list of panels. Exact list of sections and the section for your presentation will be announced after the review process.



## Submission:

**Deadline for applications is December 15<sup>th</sup>, 2019**

An applicant can only submit one abstract for the Conference either as a single author or in co-authorship. In case an abstract is submitted in co-authorship both authors should be mentioned in one application. Each abstract should be linked with one of the topics listed above. Detailed abstract requirements are listed in the Annex 1.

All abstracts are subject to blind peer-review by two independent experts according to the topic indicated in the application. Notification of acceptance will be e-mailed to the applicants by **January 20th, 2020**.

Based on the results of panel presentations participants will have an opportunity to publish extended abstracts describing their research and its results in a printed journal. Participants, whose presentation achieve recognition, will be given the opportunity to publish a full-scale article in the same journal that would be indexed in Russian Scientific Citation Database (RSCI).

The Organizing Committee reserves the right to reject those abstracts that do not follow the requirements or are submitted after December 15<sup>th</sup>, 2019.

## Scholarship

Participants from other countries may apply for a scholarship for travel and/or accommodation.

To apply for funding one should:

- answer a special essay question in the Application Form
- provide a CV (with brief description of one's professional and academic achievements)
- provide a scanned copy of a Letter of Recommendation signed by a research advisor.

When applying for the scholarship applicants agree with the following statements:

- 1) The host side pays for the tickets and/or accommodation. If a participant buys tickets or pays for accommodation on one's own, these expenses are not refunded.
- 2) Only the tickets from the city of departure to Saint Petersburg and back to this city are paid for.
- 3) The host side discusses the more convenient dates of departure to/from Saint Petersburg with participants, but still maintains the right to offer final date and time. Participants may agree with these dates or refuse and pay for the tickets on their own.

All documents for scholarship application (CV and Letter of Recommendation) should be submitted together with the abstract **by December 15<sup>th</sup>, 2019**.

The applicant is expected to be the presenter, i.e. the first author of the submission.

We remind you that you can also travel to the Conference at your own expense or seek financial assistance from your own University or Institute.



**IMPORTANT:** Please, note that **Russian Visa Policy** requires participants from other countries to apply for a visa (please check in advance whether you need a visa [https://en.wikipedia.org/wiki/Visa\\_policy\\_of\\_Russia](https://en.wikipedia.org/wiki/Visa_policy_of_Russia) or contact us). After the review process authors of accepted abstracts will get visa assistance.

## Abstract Requirements

The abstract should be no more than **3000 characters** including spaces and Reference List. Each abstract should clearly present a research question/hypothesis; critical review of the literature; methodology; results and conclusions. Preference will be given to works proposing original ideas and approaches.

Tables, images and figures are not permitted.

Information about supporting grants may be presented at the end of the abstract.

### Referencing:

The Reference List must contain no more than 4 references. It should include all those and only those sources that appear in the abstract. Reference List is submitted via a separate window. References in the text are indicated by a number in square brackets in order of appearance. Footnotes or endnotes are not permitted.

#### In-text reference examples:

John Smith's experiment [1] showed...  
This fact is well known [2; 3; 4]  
As James Smith stated [5, p. 25]

**All abstracts will be evaluated according to the following criteria:**

1. Scientific contribution - problem explored in a research is up-to-date and is of interest for scientific community.
2. The problem/hypothesis/research question is clearly stated.
3. Abstract includes the description of the methodology used in the research. The methodology is suitable for the research question/hypothesis stated.
4. Author relies on the previous research or existing theories related to the stated problem and provides necessary references to support one's claims.
5. Existing or expected results of the research are described. The results comply with the stated problem/hypothesis.
6. Abstract is written in accordance with the norms of academic writing. Thoughts are expressed logically, using scientific language.
7. Abstract does not contain any signs of plagiarism or any other forms of scientific ethics violation.
